

Wardour

1. The Lordship and manor or reputed manor of Wardour with its rights, members and appurtenances and the castle of Wardour with the buildings, orchards, gardens and curtilages thereunto belonging and all woods, underwoods, woody grounds called by the names of the Hangings and New Coppice and several parcels of meadow or pasture grounds called by the names of Greatmead, Uppermead and Lowermead, Pondmead, Upper Cowleaze, Pond Close, Walnut Orchard and Horseleaze with all the other the lands and tenements and hereditaments thereunto belonging with the appurtenances in the parish of Donhead St Andrew. Now in my own possession.
2. The parks of Wardour called Fallow Deer Park and Red Deer Park with three parcels of meadow or pasture with the appurtenances in the several parishes of Donhead St Andrew and Tisbury. Now in the possession of Edward Doling and John Haylock. Tenants at will. Rent £200 a year.

Manor of Donhead

3. The manor or reputed Manor of Donhead in the parishes of Donhead St Mary and Donhead St Andrew; Court Leet and View of Frankpledge in and for the Liberty of Donhead; Court Baron with Lawday silver and other profits and perquisites, felons goods, waifs, strays, deodands, heriots and other casual profits.
4. The rectory or right of patronage to the parish church of Donhead St Mary. Now in possession of Rice Adams, clerk, the present incumbent. The next presentation being granted by Thomas, late Lord Arundell to some person or persons in trust for the said Rice Adams, his executors and administrators or assigns (as I am informed).

The next presentation being granted by Henry late Lord Arundell and the following or subsequent presentation being granted by Thomas late Lord Arundell to some person or persons in trust for Matthew Bowles, his executors, administrators or assigns (as I am informed).
6. Several freehold tenements granted time out of mind to several persons and their heirs in fee. Chief rents payable to me amount to £5 5s 1d or thereabouts.
7.
